President's Message:

lot has happened in the past couple months and the staff at the District Office have been busy supporting members on a variety of issues. I would like remind everyone to be cognizant of the types of comments that are made to students and to classes and how the students may perceive these comments. Many comments and actions which may be perfectly clear to one person may be perceived as offensive to another. Perception isn't always an easy thing to predict but if we all remain professional with our comments and try to avoid the use of slang, sarcasm and innuendos, we can limit the probability of something being misinterpreted.

The POR situation continues to be unresolved and the Board is moving ahead with the implementation of their new model. I have had many conversations with the Provincial Office regarding this situation and we seem to be in a grey area regarding process and estoppel notification. We will not be able to grieve the changes until a violation of the current process occurs (such as an incumbent not being successful in maintaining their current position). Should this occur, the local grievance committee will meet to decide on the merits of the grievance and follow the grievance procedure as outlined in the Collective Agreement. This may take some time to resolve, especially if the issue is taken through the arbitration process, and in the meantime all our members who are going through this process need to be aware of what the new process is. Incumbent at the end of your POR?

The first POR vacancy list will be posted on Nov 14, 2016. All PORs whose term ends June 2017 will be listed, and there will be no indication of 'incumbent will re-apply'.

If you are an incumbent whose term is ending this year, and you have decided whether or not you will reapply to your POR, you are invited to inform the D16 office prior to 3:30 pm Friday Nov 11, 2016, by phone at (905)836-5954 or by email to d16.office@osstfd16.on.ca. Please use the subject line 'INCUMBENT' and provide your school name and the POR (subject) you hold, as well as whether you will re-apply or not.

Beginning on Nov 14, 2016, any member may call or email the D16 office to ask, regarding a specific POR vacancy, "will the incumbent re-apply?", and the office will be able to answer "YES", "NO", or "We Don't Know".

Are you working part-time and looking to increase your FTE?

his year the Board will pilot a Mid-Year Transfer
Process for the purpose of allowing part-time
secondary contract teachers to increase their FTE.

Briefly, any part-time teacher will be able to apply to any posted Semester 2 vacancy at a higher FTE than their current Semester 2 assignment. In other words, a part-time teacher may apply to a vacancy in another school only if the teacher's current Semester 2 assignment is less than the posted vacancy. For example: a part-time teacher currently assigned one section in Semester 2 may apply for transfer to vacancies of two or three sections. A part-time teacher currently assigned two sections in Semester 2 may only apply to a three-section vacancy. Teachers whose current assignment is in Semester-1-only may apply to any Semester 2 vacancy.

There will be three vacancy lists. The first vacancy list, to be posted Monday December 12, will be open only to Part-Time contract teachers to increase their FTE in Semester 2. The second, to be posted Wednesday December 21, will be open to part-time teachers to increase their FTE, and to OTs who will be considered in compliance with Reg 274, if there are no contract teacher applicants for the position. The third vacancy list will be posted January 16, 2017, for OTs only (for new contract hiring).

Schools who have vacant sections for Semester 2 must first offer those to part-time teachers in the building, in seniority order. After each round of transfers, any school with new vacancies must offer those within the building before posting on the next Vacancy list.

The new Secondary Staffing Timelines, incorporating this new process, are posted on bww under Secondary Staffing, and will be available to all members through our website.

Health & Safety Committee

Indoor Temperatures During Cold Months

Are your job duties normally indoors? Is the temperature in your workplace or classroom below 18 degrees Celsius? If you answered yes to both of these questions, then inform your Principal/Supervisor that the room falls below the limits as set out in the Occupational Health and Safety Act (OHSA).

The following are the sections of the OHSA regulations that apply: 128.

- (1) Replacement air shall be provided to replace air exhausted.
- (2) The replacement air shall,
 - (a) be heated, when necessary, to maintain at least the minimum temperature in the workplace specified in section 129;
 - (b) be free from contamination with any hazardous dust, vapour, smoke, fume, mist or gas; and
 - (c) enter in such a manner so as,
 - (i) to prevent blowing of settled dust into the workplace,
 - (ii) to prevent interference with any exhaust system,
- (3) The discharge of air from any exhaust system shall be in such a manner so as to prevent the return of contaminants to any workplace. R.R.O. 1990, Reg. 851, s. 128.

129.

- (1) Subject to subsection (2), an enclosed workplace shall be at a temperature,
 - (a) suitable for the type of work performed; and
 - (b) not less than 18 degrees Celsius.
- (2) Clause (1) (b) does not apply to a workplace,
 - (a) that is normally unheated;
 - (b) where the necessity of opening doors makes the heating of the area to the temperature specified in clause (1) (b) impracticable;
 - (c) where perishable goods requiring lower temperatures are processed or stored;
 - (d) where radiant heating is such that a worker working in the area has the degree of comfort that would result were the area heated to the temperature specified in clause (1) (b);
 - (e) where the process or activity is such that the temperature specified in clause (1) (b) could cause discomfort.

The Principal/Supervisor must then investigate the situation, have the problem rectified or relocate you to another work area such as the cafeteria, gym, library or another classroom. If the Principal/Supervisor does not act in a reasonable length of time and you believe that the condition is injurious to your health and safety, you may exercise your right to refuse unsafe work, under section 43 of the OHSA. If you believe this is the case please contact Scott West at the D16 office.


OSSTF PA Day May 5th, 2017

Vimy Ridge: Anniversary

he 100th anniversary of the Battle of Vimy Ridge will be marked in April 2017 with special events in France and Canada. The First World War's Battle of Vimy Ridge was fought April 9 to 12, 1917, in northern France. There, the Canadian Corps won a remarkable victory over the Germans, capturing the heavily-defended ridge that the Allies had previously attempted to take.

The 2016 Veterans' Week poster features the Canadian National Vimy Memorial in the foreground. This beautiful and richly symbolic monument commemorates Canadians who served during the bloody First World War. Engraved on its walls are the names of the 11,285 Canadians who died in France and have no known grave. Two towering pylons sitting on a massive base represent Canada and France. The monument also incorporates 20 large stone sculptures of figures that represent ideals for which Canada fought, such as truth, justice, hope and peace.

In the foreground of the poster, "Canada Bereft" is featured in detail: a striking statue of a woman, her chin forlornly resting on her hand as she gazes downward brooding over the graves of her valiant dead. The statue represents those who were left behind to mourn their loss.

An historical photograph taken during the Battle of Vimy Ridge completes the poster's design. It depicts the advance of the Canadian Corps' 29th (Vancouver) Battalion across No Man's Land and through the German barbed wire at Vimy. In total, some 3,600 Canadians lost their lives and over 7,000 more were wounded.

2017 marks the 150th anniversary of Confederation. It is very fitting that this same year includes the centenary of the Battle of Vimy Ridge, where many suggest that Canada came of age as a nation. (Veterans Affairs Canada, 2016)



The Board has assured us that incumbents reapplying in good faith for their POR will be granted an interview, unless there have been concerns explicitly addressed with the incumbent during the current term. Before deciding not to grant the incumbent an interview, the Principal will be required to discuss the decision with the Superintendent. If the decision is not to grant an interview to the incumbent, the principal should have documented a process of addressing concerns regarding their performance of their professional and POR duties. After the interview, if the incumbent is not successful, the Principal must review the decision with the Superintendent.

Any unsuccessful applicant for a POR is entitled to feedback from the interviewer(s).
